Details of registration fees:

Payment :

An order form will be sent to you as well as a confirmation of registration.

The sums are in Euros and must be paid in Euros. VAT is not applicable, according to article 261-7-1 of the French General Tax Code

Payment methods offered:

ayment by credit card (CB, Visa, Mastercard or American Express): In accordance with our commitment to payment security, all online payments by bank or credit card are made via the "Pay-Pal" security system. which allows the encryption of your bank details during their transmission.

Payments by bank transfer or cheque must be received at least 15 days before the symposium, i.e. April 19, 2022 for registration to be effective. The purchase order number must be recalled.

Cancelation:

Cancellations are made exclusively in writing. Any registration canceled less than 1 month before the date of the event, i.e. from April 13, 2022 will be invoiced and will correspond to 10% of the registration price.
